Membership Recruitment Contest Credit / Ballot Determination Rules:

- a. When a person refers a prospective member, that person's name shall go on the application form before it is sent out and that person shall receive credit for recruitment if that person signs on.
- b. If a new member signs on without listing a person as having recruited him/her, the Membership Director shall confer with the Director of Resources to see if there is any record of a referring member. Where there is record of a direct referring member, that person shall be given credit.
- c. Where there is no direct evidence of a referring member under "b" or a person's name appears on the New Members List without listing a recruiter, or the person is a "walk-in" or a cold call for membership information, the Membership Director shall have complete discretion to either list him/herself as the recruiter or assign credit to a member of the Membership Committee.**
- d. The President shall have final say in any dispute over assigning credit of recruitment.
